There is disagreement about visibility of interface intents to clients and services

Michael R thinks that the current spec allows for intents to be attached to interfaces already

Sanjay thinks that client may use different copy of interface definition that may not have the same intents

- suggests a simplification of the language based on this

Michael R thinks it is important to say why intents might be specified on an interface

<debate on these points>

Anish suggests modification of wording to allow editors to fix RFC2119 keywords.

Michael R suggests RFC2119 wording should not be used for end-users. Anish would like the words replaced entirely with non RFC2119 words.

Dave B suggests removing final sentence.

Anish makes suggested changes to the wording. "Intents can be specified on interfaces when they are be seen by both the provider"

Issue #8: Add conversational intent to Policy Framework

(Michael Rowley) - Conversational intent is described in Assembly spec

- add wording in the Policy spec that is a reference to the Assembly material

Anish – here is some proposed revised wording

This intent is meant to be used on an interface , and indicates that the interface is "conversational" as defined in the SCA Assembly Specification section 1.5.3 (or whatever section it ends up being).

Mike Rowley moves to resolve the issue with the revised wording

Anish seconds

Accepted unanimously.
