Anish: WS-I doesn't have a policy assertion for its profiles, \*yet\*. What ws-i has at this point is CCAM -- conformance claim attachment mechanism, which says how the claim can be attached to a WSDL doc or UDDI. I'm hoping that ws-i will come up with a way to specify profiles thru ws-policy. These intents would be getting SCA "ahead of the curve".

Michael Rowley moves to open the issue

**Resolution: 4. Issue 36 is moved to open state.**

Further discussion of Issue 36:

Mike Edwards argues that it is useful to indicate that a service or a reference is intended to conform to some WS-I profile - even if there are no standard policies, it is still then incumbent on the binding implementation to provide the binding in a compliant form.

Michael Rowley indicates that the function is still useful even if it is not possible to advertise the compliance of a service to non-SCA clients

Anish thinks it is useful to have the intent with the hope that policy will get standardized at some future point for the WS-I profiles
