Ashok points out that there is very little difference between WS Policy 1.2 and 1.5 and also that the SCA Policy spec does not make much reference to the details of WS-Policy, so there is little problem moving straight to 1.5

Michael Rowley thinks that each qualifier needs the capability to have a description

Mike Edwards thinks that the sentence "For each qualifiable intent the SCA system MAY declare a default qualified intent." should not mentions "the SCA system" since it is the writer of the intent definitions that has the choice to declare a default qualifier.

Dave Booz wonders whether the paragraph starting "'For each qualifiable intent the SCA system MAY " should be moved into the description of the @default attribute

Michael Rowley: The sentence that currently points to (4.10) should instead say: "The default qualifier is used when an explicit qualifier is not specified."

Michael Rowley - section 4.10 is going to need changes too - cannot close this issue until that's done
