Ashok: the item still to resolve is whether for every intent definition you are REQUIRED to supply a default or whether it is optional. Proposal is to change the proposal to REQUIRE the identification of a default qualifier.

Mike E: Outlines the proposal material

**A modification for rule #3:** Rule 3: For a composite used as an implementation by a higher-level component, if the higher level component applies implementation intents to the composite, those intents act as if they are attached to the <composite/> element. If any of the intents are mutually exclusive with the intents on the composite element, they are ignored. The remaining intents on the composite element are applied to components contained within the composite as defined by Rule 1 for the structural hierarchy.

Sanjay - Not comfortable with Rule 3, which in effect provides a means of "external attachment" of intents. It can lead to imposing intents never envisaged by the developer  
- Allowing intents to be expressed in this way does not sound correct

Ashok - my question is a bit different. If you add implementation intents at the higher level, what do you do with them? Do you throw them away?

<Discussion of usecases for intents to be attached within a composition, rather than within each implementation>

Mike E: It would be useful to have some examples where there is a problem caused by the application of an implementation intent at the higher level composite which then affects the operation of components in the lower level composite
