##### **ISSUE 24: More direct, structural qualifier definition**

Ashok: main remaining item was whether default was a REQUIRED item.

Sanjay: How can we get the right proposal in front of all of us?

<confusion over the document versions that people can see>

Changes to section 4.10 are included in this latest version

Ashok: 2 changes

a) remove the paragraph about the constraint under the schema (lines 215 / 219)

b) change wording of default attribute

Michael Rowley: Delete: "If an intent definition has more than one qualifier children then only one of them may be declared as the default."

Michael Rowley: Delete: "Constraint: If the intent definition contains one or more <qualifier> children, one and only one of the qualifier children MUST have the value of the default attribute set to true. The values of the name attributes of the qualifiers within a single intent definition MUST be unique."

Michael Rowley: Keep: "If the intent definition contains one or more <qualifier> children, one and only one of the qualifier children MUST be designated as the default i.e., have the value of the default attribute set to true. Further, the names of the qualifiers must be unique."

Michael R moves to resolve Issue 24 with the identified proposal document with the changes listed in the lines above
