Sanjay discusses proposed new issue 59.

Having a policySet attached to a high-level node creates a limitation on the bindings that can be used.

Ashok: 2 questions --

1) attaching a policySet high up is a shorthand, why remove this

2) did you want to disallow attaching policySets to interfaces?

Sanjay: Yes, that can be done via intents

DaveB: Should limit proposal to interaction policies but we do not distinguish between interaction and implementation policies

Sanjay: moves to accept issue. DaleM seconds

Resolution: Issue 59 is opened.
