Dave: First suggestion is to "raise the bar" for the creation of new issues - 2/3rds majority required to raise new issues after a given date (Sept 15<sup>th</sup>)

Mike E: Moves to change the requirement for raising a new issue to require a 2/3rds majority of the TC, as from September 15th  
Bob F seconds

Bob moves to clarify: 2/3rds majority of a quorate meeting
