The changes for Issue 42 are all noted by Word comments

Ashok: Q1 - you can add a PolicySet using an optional <policySetAttachment/> child element - but can you attach a PolicySet directly inline?

Dave - I think that the proposal matches the agreement from the F2F

Ashok: Q2 - can there be multiple PolicySets attached in this way for a given SCDL element?

Dave: Yes

Ashok: Can this be termed "PolicySet References"?

Dave: Thought that this might clash with another use of that term "reference"

Dave: We could change to use the PolicySet Reference and avoid having 2 concepts

Sanjay: but is this useful - is it really making things simpler here?

Ashok - we need to open an issue in the Assembly TC for the corresponding changes

Ashok: Other items that I have are about the spec draft where changes were made but there was no mention of "external attachment"

Dave Booz: minutes from Oct 2:

"Ashok moves that we agree on a direction for the resolution of Issue 46 so that policySets can be specified EITHER in the way currently described in the specification (@policySet attribute) OR through a new mechanism of using a child <policySet/> element where these child elements are optionally available for all elements that today have the @policySet attribute"

Dave moves to resolve Issue 46 using the text as marked in WD-09. Mike E seconds.

Resolution: Issue 46 is resolved with the text marked in WD-09 of the Policy specification
