Ashok discusses the Test Assertions document - PolicyTests.doc

Assertion POL-TA-30001

Ashok: How can this be tested?

Dave: An example would be a <binding.ws/> element with a wsdlElement attribute pointing to a WSDL that implies using a non-SOAP messaging binding, but which has the SOAP intent applied to it - the intent is in conflict with the binding configuration in this case as the implied transport is not able to use SOAP.

Mike E: Comments that ideally, the Predicate is a simple statement that is either TRUE or FALSE (typically stated in the "true" form)

Assertion POL-TA-30007

- need to restate the "IF" as one or more prerequisites, such as 1) Intent which is a profile intent...

Ashok: 2) no policySet directly satisfies intent

Assertion POL-TA-30011

Ashok: Is it testable?

Mike E: Yes, it probably is testable - the assertion is valid, but to write the testcase would depend on knowing a lot about a particular binding and the testcase would take a lot of effort to build

Ashok: For 30011 we say we will not test this

- so write the assertion but not the testcase itself

Ashok: 30015 needs negative test

Ashok: 30017 also needs negative test

Ashok: Eric will take a look and try and improve wording for assertions until 30022.

Ashok: Ashok will work on later assertions
