Eric: No idea how to test this one.

Simon H: There may be examples in the Bindings spec which do show where there are conflicts - I will do some investigation and post to the list

POL-TA-30004

Eric: I think that there is an issue with the normative statement about the @default attribute of an <intent/> - I will raise this.

POL-TA-30006

Mike: I'm confused by the prerequisite statement - <intent/> with @requires IS a profile intent, but the target is a "profile intent"

Ashok: How about removing the word "profile" from the predicate and prerequisite fields and add explanation in parentheses in the target description

Ashok: I'll do that update

Eric: Same will apply to POL-TA-30007

POL-TA-30007

Mike: I think the target is not an SCA Runtime, rather it is the element with a profile intent attached to it - the problem then reduces to writing a test that probes what (atomic) intents apply to that element - and I can envisage a (complex) testcase that can do that.

Eric: OK, will change the target
