Dave: There may be a problem with that. Test Assertion doc needs to go into public review - and it should match the Public Review level of the spec.

Anish: Do they really have to be in Sync? As long as the Test Assertion doc points to a publicly available version of the spec...

Martin: You can't make changes while you are in public review. So a new CD is not really on.

Anish: Can't it reference a revision - does it have to be a CD?

Martin: The problem is that it should refer to a committee approved document - ie a CD or better.

Dave: That is why I think that the Test Assertion doc must reference the PR document

Martin: It might be OK to do a CD which is not published on main OASIS site.
