Ashok: Do we need to profile the TA's  
EricW: Depends on how many optional normative statements in Policy spec  
...If they're related then will need to group and hence groups TA's also

DaveB: Related to POL-40014 - may need to do more work on this  
...Saying that implementaion hierarchy needs to be considered in some cases & this is one  
Ashok: Prereqs on 40014 need to be more speccific.  
Ashok: In 40019 we say intents attached via WSDL extension. direct attachment to interface or on the component type all must be accounted for in the implementation hierarchy  
DaveB: attached to reference to interface
