- may want a test for users defining new intents or extending intents
- I will leave it to the committee to decide

Ashok: Do you recommend that we add wording to the spec to clarify some of these questions

Rich: I think some wording should be added to the beginning of Appendix B

- the factual side of the material should be based on the test in the email, but the text is not suitable as it is
