Anish - I really dont think that the SHOULD wording is good since it undermines the model. I think it should be a MUST - SHOULD demolishes portability

Dave - this is really the resolution of Issue 79

Anish is suggesting the reopening of Issue 79

Mike: I agree with Anish

Dave: I also agree with Anish

Ashok: Should we revisit 79 or simply deal with the wording under 110

Ashok: My mail had a specific proposal to enable marking of intents with "Ignorable" or "NotIgnorable"

Mike: I think that makes the model more complex just to avoid making a decision

Mike: Do people object to the idea of changing the normative statement to a "MUST"?

Eric moves to reopen Issue 79
