SCA Policy Framework CD02-Rev6-Issue93Rev7.doc

Dave: The change markings in this version are ONLY from the previous rev of this proposal - not from Rev6 of CD02

Ashok: What did you do?

Dave: We accepted all the changes from the last version of the proposal and then made edits

Dave: First changes are in Section 4.3

- "externalAttachment" element, rather than "intentAttachment"

Dave - next changes are in Section 4.6

Dave - then next changes are in Section 4.14

a) intentAttachment -> externalAttachment

b) Remove redundant paragraph

Dave - next changes in Section 4.14.1

Ashok: First paragraph of 4.14.1 needs to be expanded to discuss why you would want to redeploy

- what is there is correct, but I think that it is useful to spell out more examples of the types of changes that can take place

Dave: I don't follow

Ashok: I'd like to see more detail on how the policy artifacts might change

Ashok: we can close Issue 93 with these words and then add the material I want to see editorially when preparing the next CD

Dave: The first major change in 4.14.1 is the extra bullet (3rd)

- describes the capability to delay activation of policy related changes

Ashok: Comment on Bullet 1

- so you stop all running instances and then redeploy, but redeployment fails - what happens then

- really I am asking when you stop the running instances if you're following the 1st bullet approach

- we should put some words in that 1st bullet to make it clear when the changes to the policy stuff are done

<discussion of whether running components are stopped or not, if there is a deployment failure>

Dave Booz:externalAttachments and/or policySets MUST NOT be deployed and no change is made to *the configuration of* deployed and running artifacts. POL40030

Dave: The normative statement changes are simply adding "externalAttachments" to the list of things involved in each statement

Dave - next changes are in Section 4.15

Dave - next changes are in Appendix A

NOTE: For the editors - Appendix A has a bad Title - "Appendix" is missing

- final changes are in the XSD (section B)

Ashok: Do you want element extensibility here?

Dave: It is already there - see the <any/> elements

Ashok moves to accept SCA Policy Framework CD02-Rev6-Issue93Rev7.doc above, with the change to POL40030 as described by Dave in the minutes to RESOLVE issue 93.

Martin seconds

Motion passes unanimously

Resolution: Issue 93 is resolved

Ashok: I'd like to discuss the schedule for the next few weeks

- next week talk about responses to the PR comments (just need to write and agree response text)
- then we are in good shape for the next PR
Ashok: Then you & I can work on the spec and ready it for the next CD
Dave: I will be occupied most of the week of 29th April, but I'm available the week of the 5th April
Ashok: Useful if we are ready to vote on a CD03 by April 11th
Dave - do you want to write some of the responses?
Ashok: I'll deal with them all
