Dave describes the update to the TA document above
Start at line 182, POL-TA-40051

Ashok: I think I'm looking at this differently to you Dave

Ashok: The changes don't take effect until you redeploy the composite affected

Mike: So for any changes to be visible, in your view you have to redeploy all the composites/component

Dave: How is redeployment of a policySet different from the redeployment of a composite?

<discussion about the process of redeployment, how it occurs>

Dave: OK - POL-TA-40052, 40053 are similar

TA-40054 is about new normative statements

TA-40055, TA-40056 are similar

TA-40057 is about another one

TA-40059, TA-40060, TA-40061 are new - about optional normatives

Next changes are @ line 284 / TA-90032 - through to line 292

Dave: I checked that all the normative statements in the spec map to this TA document and also that the cross-ref in the TA doc is correct

Ashok: Naming the CD level TA document? Should we name it the same as the spec? eg CD04?

Dave: Confusing if there was never a CD01 of this document

Ashok: Do we need to go to CD04 for the spec?

Dave: My plan for the spec is to apply the issue to the CD03 candidate and publish that as "CD03"

Dave: I'll build those documents - both the spec and the TAs
