Ashok: One of the include statements for the Policy XSD was incorrect - discussed last week:

- resulted in one small change - spec contained an XSD referencing an incorrect version of the core SCA XSD

- So the revised files contain the spec with this change and the relevant XSD files

Mike: We need to make it clear that the XSD and XML file in the ZIP are the same as already on the OASIS site for the SCA namespace here:
