OASIS plans to organize a Security Standards Showcase on the RSA 2018 exhibit floor to provide visibility--and marketing opportunities--for OASIS members. **Reservations are open to Foundational- and Sponsor-level members until 1 April. Contributor members may apply after 1 April.**

In 2018, the OASIS Showcase will feature support of KMIP, PKCS #11, and Cyber Threat Intelligence suite of standards. Members who reserve pods must showcase support for one or more of these standards and are encouraged, but not required to participate in one or more Interop demo(s). Technical requirements for Interoperability will be determined by the members involved. Members who successfully participate in Interop demo(s) will be highlighted in a separate press release and receive recognition via signage or other in the booth(s).

Reserving a pod secures a member's right to participate in RSA 2018 even if they: a) choose not to participate in an Interop Demo; or b) are unable to meet the technical requirements of an Interop Demo.

All Participants will operate out of the OASIS Security Standards Showcase booths, coordinated by OASIS staff. OASIS staff will work directly with the confirmed participants on booth layout. Promotional opportunities coordinated by OASIS staff will be available before, during and after the event.

Please note: Internet connectivity is not included in the participation fee, due to rising costs. OASIS staff will secure internet access for any participants who require it, subject to an additional fee (cost to be evenly distributed among participants who reserve it).
