This is a review of the EML needs identified by the previous P1622 Working Group against the current version 6 of EML.

Items are color coded to facilitate review. Those colored **blue** are resolved. Those colored **red** are not resolved. There is an item colored **burnt-orange** to indicate it needs tweaking. **Green** is used to color code some of the comments in the EML examples.
