
This copyright assignment is made on this 14th day of July, 2015, by The Regents of the University of California ("The Regents"), a California public corporation acting on behalf of its San Diego campus having an address at University of California, San Diego, Technology Transfer Office, Mail Code 0910, 9500 Gilman Drive, La Jolla, California 92093-0910.

RECITALS & WARRANTIES

1. DuraSpace is an independent 501(c)(3) not-for-profit organization providing leadership and innovation for open technologies that promote durable, persistent access to digital data.
2. DuraSpace serves as the organizational steward for the Hydra software ("Hydra"), an inter-institutional collaboration that provides a discovery and display interface for Fedora, an open source framework for a multi-function, multi-purpose repository.
3. Hydra provides unique and significant opportunities for The Regents because, among other things, it provides a front end platform for a robust system for the management and dissemination of digital content at considerably lower costs than "closed source," proprietary solutions. Hydra is especially suited for the discovery and display of digital libraries and archives of historic and cultural materials as well as scientific data, including such libraries and archives owned by The Regents.
4. Hydra has selected Apache License, Version 2.0 as the open source software license for the distribution of, and contributions to, Hydra.
5. The Regents, through its San Diego campus, intends to participate in Hydra by, among other things, developing enhancements and other modifications to Hydra. In doing so, The Regents, through its staff members, will create and contribute copyrightable works of authorship ("Works") to Hydra. The Works are disclosed in, and are part of, UC San Diego Case Number 2015-826.
6. The Regents warrants that: (a) it is and will be the owner of the copyrights in the Works; (b) its ownership interest is and will be unencumbered; and (c) it has the full and lawful right to assign and convey the copyrights in the Works.
7. In order for The Regents to participate in Hydra, The Regents has determined that it will assign its copyrights in the Works to DuraSpace.
8. The Regents has determined that participating in Hydra furthers its educational and scientific purposes and that assigning the copyrights in the Works to DuraSpace is in The Regents' best interests.

ASSIGNMENT

In consideration of the benefits to The Regents in participating in Hydra (as described above) and for other consideration, The Regents hereby assigns to DuraSpace, all of its rights, title and interest in the copyrights to the Works. This assignment applies to DuraSpace, its successors and assigns, for and during the existence of the Works' copyrights and all renewals and extensions thereof.
