In February, Google joined as a new Associate \$105,000 and Modii joined as an Associate \$10,000. A contribution of \$10,000 was received on behalf of the City of Philadelphia.

Accounts Receivable at the end of February was \$125,625 (see attached)

Expenses for February were under budget based on the contracting work funded by the Rockefeller Grant has been extended until the end of April.

Cash on hand at the end of the month was \$322,881 a decrease of -\$ 52,290. Of this balance, \$90,645 is designated to Rockefeller Grant Activities.

The number of Months of Operating Cash has increased to 5.2 months and Cash vs Deferred Revenue has increased to 102%.
