Mike Edwards: Are documents conformance targets?  
Anish & Martin: Yes, they can be required to conform eg to a schema  
Ashok: No, I take a contrary view - its the entities which are described by the doc which must conform  
Anish - Schema does not capture everything about a document. Useful to consider conforming docs vs non conforming - how to process each type  
Ashok: How to proceed?  
Mike Edwards: Suggest that someone (anyone) should put a proposal to the email list to start discussion  
- OK leave discussion at this point and continue on the mail list
