Michael Rowley asks the question as to why the existing specification is not clear. Can we close the issue without new text being required?

Dave Booz - asks whether this document should be folded into the main Policy specification

Martin Chapman: If it is separate, then it gets its own lifecycle and review process. Might be possible to have separate physical documents but for there to be one logical specification, handled as a single entity from an OASIS process viewpoint.

No further action at this point - bring back in later meeting

***(Item 8) New Issues***

There are no new issues.

***(Item 9) Conformance Targets***

Discussion of what is needed beyond a) SCA Artifacts and b) SCA runtime. "SCA Runtime" may be too large and "amorphous".

Michael Rowley thinks that there may be different aspects / parts to the runtime.

Martin Chapman thinks that there may be different kinds of runtime with varying capabilities - not sure how this may be described - deployment aspects vs execution of artifacts, for example.

Dave Booz asks for a volunteer to build a proposal

**Issue #15 - External Policy Attachment**

Ashok explains the proposal, as made in the email:

Mike Edwards: The XPath expression - is it meant to point to one particular place in one SCDL artifact or to many places?

Ashok: It is meant to apply to multiple places

Michael Rowley: Some of us think that the XPath multiple target identification is a good thing.

Mike Edwards: I'd really like to see examples of the use of this for the major usecases

Mike Edwards: What are the intents being used for in the <requires/> elements?

Ashok: These intents are applied (externally) to the target elements (as identified by the XPath) ...and the effect is the same as attaching those intents directly on the target elements

Dave Booz: So does XPath expression take into account both Hierarchies - SCDL hierarchy and Implementation hierarchy?

Ashok: Only applies to the SCDL

Dave Booz: PolicySets can include the various Policy elements - they are included here as well, which sounds like this new idea circumvents the PolicySet functionality

Ashok: Well, there is an issue open for this capability...regarding the need for external attachment

Dave Booz: We have open issues for operation and message level attachments. Can this proposal solve those issues - without the need for <operation/> elements?...ie do the attachment by reaching down in this XPath way down through the interface

Ashok: Yes, it looks like it could be used to do that, at least for WSDL interfaces

### **Issue #38 - Improve description of the overrides available to the two different hierarchies in SCA**

Michael Rowley moves to close with no action

No second - motion fails.

Michael Rowley - Policy spec makes use of the XML hierarchy and describes the defaulting down the XML hierarchy. Other form of hierarchy is described in the Assembly spec - where components are implemented via composites which forms another type of hierarchy. The latter hierarchy does have policy implications - intents can be added or further qualified by the second hierarchy. There is no place that brings these together

Mike Edwards: I believe that some explanatory text is definitely required
