Ashok outlines the discussion that took place last week.

Michael Rowley: 2) Outgoing requisition messages should be signed using this policy, when binding.ws is used `//output[@message=tns:RequisitionMessage]/binding.ws`

...this is one of the key usecases

Ashok: `//binding.ws/..//output[@message=...]` is an alternative

Michael Rowley: Or even .... `//output[@message=...]`

<Discussion of alternative designs>

One difference is the need to copy the port type multiple times in the alternative design where the binding is above the Port type.

Ashok: Suggestion - create an alternative proposal with the binding not brought underneath the messages, and then express the XPath expressions for the examples

Michael R: Not sure that this deals with an Authorization usecase (that is described) ...which can be applied to a given operation irrespective of the binding

Michael R - there is also the question of what the XML document looks like after the rules are run - the more duplication, the worse it is

Ashok - I'd like to see this written down so we can work on it

Ashok - I will take the previous writeup and change it so that Port Type is below the Binding - and we can work on it and send it out to the list.

Michael R outlines the problem described by the Issue.

There are cases where you need to express the attachment of Policy only after SCA has (pre)processed the composite files.

Ashok: So you do a bunch of pre-processing and then apply the policy using attachment mechanism. It is the specifying of the pre-processing steps that is important here

Michael R: Yes - that is the main point of the issue.

Ashok: Where do the processing steps get written up?

Michael R: Should be in the Policy Spec, probably referencing material in the Assembly specification

Ashok: Someone needs to build a formal proposal for this.
