#### **Issue 15 External Attachment of Policy**

Ashok - has updated the proposal with more detail.

Ashok describes the latest proposal document:

Michael R: The uri handling is dependent on resolution of URI handling under discussion in the Assembly TC. 2 alternative approaches to the URI are being discussed there.

Dave B: Either proposal will result in URIs that are usable within this proposal - the question is whether the URI is customizable.

**Action 20080414-01: (Michael R) Write an email to the list describing the detail of the difference in the alternative URI proposals**

One other problem is the fact that bindings are siblings of interfaces. The proposal shows how this is handled.

Ashok: Is there enough agreement on this direction?

Michael R: When could we discuss the bigger issue of this proposal versus the "pull" style of policy attachment?

<Discussion of this point>

Mike E: Argues the position of effectively removing the "pull" style of attachment – intents are still attached to entities like services, references, but they simply state requirements – actual attachment of PolicySets is entirely down to the "push" mechanism described in Issue 15 resolution. The concept is one of simplicity and not having to describe how clashes between "pull" and "push" mechanisms would be handled.

Ashok expresses concern over what happens to direct attachment of PolicySets to artifacts (Mike E argues that this should be removed too...)

One interesting point to emerge from this is the idea that XPath functions might be defined for common aspects of policy attachment, which might otherwise be more tricky to express in "pure XPath".
