Ashok discusses the email above
Ashok: the question is whether we change the @appliesTo XPath evaluation - to use the Domain infoSet
Ashok: I think that it is simpler
Dave: What's the advantage of doing it from the composite root level?
Ashok: If you attach a policySet which is attached to the root composite element you would have to add context elements at each level with the current specification, and changing to use the Domain infoSet should be a lot simpler

Dave: Your concern is that the SCA runtime is going to have to iterate through all possible places where <binding/> can appear and check if the policySet applies there. What you want to change to is an XPath against all composites
Dave: Main use case is that you know that a policySet is associated with a given type of binding, then @appliesTo is for that (eg binding.ws)
Dave: So you're arguing that it would be simpler for (deployers etc) to use the same context root for both attributes
