Dave: I don't see a description of the <requires/> element in the proposal

Ashok: But the <requires/> element is in the Assembly spec - that is where the schemas are

Mike: But the Assembly spec basically points to the Policy spec for the @requires and @policySets attributes - and it would be the same for this <requires/> element

Dave: We need a schema update in the Policy spec

Dave: This looks like the <policySetAttachment/> element which is in the Policy schema document

Ashok: OK, I'll look at this

Dave: I think we have a hole in relation to <policySetAttachment/> element - the Assembly spec does not say anything about this.

Ashok: Mike provided an update to the wording I proposed, since it had an RFC2119 keyword...

Ashok: Mike suggests: "The normatively defined intents in the SCA specification might evolve in future versions of this specification. New intents could be added, additional

qualifiers could be added to existing intents and the default qualifier for existing intents could change. Such changes would cause the namespace for the SCA specification to change."

Ashok moves to resolve Issue 106 with the words in the minutes above.
