Ashok made a proposal, then there have been additions/changes by Mike and by Dave
This latest version has a couple of comments inline:

1) Section 4.1 - there is an implied change in the Assembly spec since it implies a new <requires/> element in a WSDL file, which is part of the Assembly spec

ACTION 20091109-01: (Ashok) Raise an issue in Assembly to permit a <requires/> subelement of a <portType/> element

2) Section A.1 sca-policy.xsd

- Dave asks if the requires element specified there has the right kind of extensibility - it allows attribute extensibility but not subelement extensibility

Ashok: It is probably a good idea to add subelement extensibility here and also to policySetAttachment elements

ACTION: 20091109-02: (Ashok) Add element extensibility for <requires/> and <policySetAttachment/> elements in the schema

Mike: Also check out the changes I made to the examples in Section 4.1
