Ashok discusses the email changes that have taken place since the last meeting

- 1) 1st the question about treating external attached intents as either/or - alternative of simply adding intents together
 - new proposal with this change has been posted
 - change is in section 4.1
- 2) Dave Booz asked for clarification of usecases
 - Ashok supplied some usecases
 - ability to change requirements based on a new deployment to a new environment
 - Dave B made the point that the proposal means using intents to express "external" requirements, whereas the current spec specifies "internal" requirements using intents
 - This makes the differences in thinking clear

Mike E - I see this proposal as essentially being a means of supplying deployment information - and that this can be done using the deployment of appropriate PolicySets with attachment specifications to the appropriate locations

Ashok: Our proposal is to allow expression of external requirements that can then be satisfied with appropriate concrete policies - it is a useful extension of the function that is present

Rich: This has similarity to defining intents at a higher level versus a lower level and where lower levels can express more detailed requirements (eg qualified intents) and the intents are separated from the actual policies that are used

Ashok moves to resolve Issue 93 along the lines of the proposal contained in

Gil seconds

Eric - we should tidy up the external/internal attachment mechanism - I don't like them being exclusive

Ashok, agree, but that is a separate issue

Mike: Currently external attachment of policies is an override, which is different

Eric: Isn't it the case that some people would not want a directly attached policySet to be overridden

Mike: Current mechanism does not support that - you could envisage a new design that provided that capability
