Mike E: If a union of directly attached and externally attached is allowed, then this means that a directly attached policySet cannot be replaced, which can be a problem.

Ashok responds: possibly we can allow replacement where the external policySet covers the same policy "domain" as the directly attached policySet

Mike raises a point about the composite containing a @requires attribute pointing at an intent which is not satisfied anywhere - this causes an error which is not intended

- finally the client

Dave: Note the list of contribution names:

"POL_3003" , "Policy_General" , "Policy_General" + _Lang

- the last one contains any implementation-language specific stuff eg.

"Policy_General_Java"

Dave: Let's look at another example:

- this is a Positive test - it should run without error and return a result to the client
