Ashok discusses Dave's version of the document

Ashok - I have 2 questions about it in general

1) Comment about Rule 1 & Rule 2 - these are about intents and the hierarchies  
Is it obvious that intents are part of the hierarchy?

Mike: Split this into 2 parts: Structural Hierarchy & Implementation Hierarchy  
Section 4.7.2 defines Structural Hierarchy and it is clear that it never involves componentType  
Section 4.7.1 defines Implementation Hierarchy - and it does involve componentType as defined in bullet #2

Here are the words from the spec:

"The implementation hierarchy occurs where a component configures an implementation and also where a composite promotes a service or reference of one of its components. The implementation hierarchy involves:

- o a composite service or composite reference element is in the implementation hierarchy of the component service/component reference element which they promote
- o the component element and its descendent elements (for example, service, reference, implementation) configure aspects of the implementation. Each of these elements is in the implementation hierarchy of the corresponding element in the componentType of the implementation."

Anish: I see that in section 4.5.1

Ashok: 2nd point - new section on Deployment

Section 4.14 - "Deployment"

Ashok describes this new section
