EricW: Regarding conformance - can we ensure that there are no bugs in the Test Suite - otherwise a MUST could cause problems?

Dave outlines the status of the Policy spec, the test suite documents and the test artifacts.
We are in a position to produce "final" 1.1 documents - CD04 of the Spec & CD02 of the TestSuite documents

Dave: So what might be the schedule for that?

- candidate documents by 15th Sept

- vote for CD on 27th Sept

Ashok: I have a conflict on the 27th

Dave: I think that we should go ahead with the 27th

(Item 11) Testing

Dave describes the need to be able to have a version of the test suite with non-Java implementation type artifacts, as done for the Assembly test suite

Dave suggests the idea of re-using the current Assembly test suite implementation type specific artifacts for this purpose - only a very few language-specific artifacts are required

Mike E agrees in general

Dave: We'd need to work on this before the final CD - ie need to work that this week
