OASIS plans to host a TOSCA Interop Demonstration on the OSCON 2015 exhibit floor to provide visibility--and marketing opportunities--for OASIS TOSCA members.

Any OASIS member of the TOSCA technical committee may participate in the Interop by demonstrating a product or service that supports the standard and by meeting the criteria as defined by the OASIS Interop Policy and TOSCA technical committee.

PARTICIPATION INFORMATION

Interop Participants will operate out of the assigned OASIS space within the OSCON Non-Profit Pavilion (estimated size = 9'x9'). The space includes a six foot draped counter and two chairs. To meet expenses, each organization participating in the Interop will be required to pay a non-refundable participation fee. The amount and deadline for payment is noted on the backside of this form. This fee is based on projected venue costs and anticipated number of participants. The fee may cover items such as signage, collateral, audio-visual equipment rentals, connectivity (internet/intranet), power, booth visitor lead retrieval, and additional furniture rental.

In exchange, each Participant will receive:

- One booth staff registration, which provides access to the OASIS pavilion space and lunch on Wed & Thurs
- Company recognition in all Interop promotions, including:
 - OASIS press release (*each Interop Participant will be highlighted, with quote opportunities for Foundational and Sponsor-level members*)
 - Interop datasheet, *featuring Participant logos and company descriptions*
 - Websites presences (*on OASIS site*)
 - Booth signage
 - Email announcements, OASIS News articles, social media outreach, etc.
- Dedicated OASIS staff support to coordinate logistics and assist in planning
